**EMERGENCY POWERS (COVID 19 PANDEMIC)(RISK
MANAGEMENT)(NO.4)(AMENDMENT) ORDER, 2020**

In exercise of the powers conferred on me by the Emergency Powers (Covid 19 Pandemic)(Risk Management) Regulations, 2020, I HEREBY make the following Order —

1. Citation.

This Order may be cited as the Emergency Powers (Covid 19 Pandemic)(Risk Management) (No.4) (Amendment) Order, 2020.

2. Amendment of order 46 of the S.I. No. of 2020.

Order 46 of the Emergency Powers (Covid 19 Pandemic)(Risk Management) (No.4) Order, 2020 is amended by the deletion and substitution of paragraph (7) as follows—

“(7) A person who is not a current guest at a hotel or other commercial accommodation situate in an island specified in the *Second Schedule* shall be required to submit a negative COVID 19 RTPCR test result in order to check in as a guest or utilizes any facility on the hotel premises including restaurants, casinos, etc.”.
