EMERGENCY POWERS (COVID 19 PANDEMIC) (MANAGEMENT AND RECOVERY)(NO.2) (AMENDMENT) (NO. 2) ORDER, 2021

In exercse of the powers conferred on me by the Emergency Powers (Covid 19 Pandemic)(Management and Recovery) Regulations, 2021, I hereby make the following Order —

1. Citation.

This Order may be cited as the Emergency Powers (Covid 19 Pandemic) (Management and Recovery)(No.2) (Amendment) (No. 2) Order, 2021.

2. Insertion of new orders 52A – 52H into the principal Order.

The principal Order is amended by the insertion immediately after order 52 of the following new orders —

"52A.Curfew for North and South Bimini.

Effective 7:00 pm on Thursday the 1st day of July, 2021, a curfew shall be imposed for North and South Bimini extending Monday through Sunday between the hours of 7:00 pm and 5:00 am.

52B. Weddings in North and South Bimini.

- (1) A wedding may be held in North and South Bimini in a church, a facility, or outdoors provided that
 - (a) the number of attendees inclusive of officiants is limited to ten persons; and
 - (b) all attendees wear masks in accordance with order 5.
- (2) No person may host or attend a wedding reception in North and South Bimini.
- (3) A person who hosts or attends a wedding or a wedding reception contrary to this order commits an offence and is liable upon summary conviction —

- (a) in the case of a host, to a fine of two thousand dollars and three hundred dollars for each person in attendance; and
- (b) in the case of an attendee, to a fine of three hundred dollars.

52C. Funerals in North and South Bimini.

- (1) A funeral may be conducted in North and South Bimini at a graveside burial only
 - (a) provided that the number of attendees shall be limited to not more than ten persons exclusive of officiants and funeral service workers.
 - (b) provided that the number of attendees is limited in accordance with the physical distancing protocol order 4; and
 - (c) subject to any protocols issued by the Bahamas Christian Council and approved by the Ministry of Health.
- (2) No person may host a repast in North and South Bimini.

52D. Beaches and parks in North and South Bimini.

All public and private beaches and parks in North and South Bimini shall be open provided that there shall be no greater than five persons in a group.

52E. Social gatherings in North and South Bimini.

No person shall host or attend a social gathering in North and South Bimini.

52F. Closure of bars in North and South Bimini.

No person shall operate or attend a bar in North and South Bimini.

52G. Operation of hotels and cruises in North and South Bimini.

A hotel or cruise ship in North and South Bimini shall continue operation provided that a guest of the hotel or passenger of the cruise ship shall remain on the premises of the hotel and cruise ship during the curfew imposed under order 52A.

52H. Religious instruction in North and South Bimini.

In North and South Bimini, a worship service may be conducted daily, between the hours of 6:00 am and 6:00 pm, in accordance

with the protocols established by The Bahamas Christian Council and approved by the Ministry of Health.".
